REMOVE NON-FRIABLE ASBESTOS

This course brochure will inform and guide you through the Master Builders Remove Non-Friable Asbestos training course. Please read the following information carefully to help you understand all the course requirements and assessments to ensure that it is suitable for your needs.

ABOUT US

Master Builders Association of NSW is a Registered Training Organisation (RTO 6163) registered by the Australian Skills Quality Authority. Master Builders offers nationally recognised qualifications and courses across New South Wales which meet endorsed industry standards. Pathways to qualifications include full training and assessment, assessment towards Recognition of Prior Learning (RPL), gap training and Continuous Professional Development (CPD).

COURSE OVERVIEW

The Remove Non-Friable Asbestos course is designed to help Participants learn how to identify and dispose correctly of asbestos containing materials in a safe way, to ensure both their safety and the safety of the people around them. This course is a legal requirement for workers who may be required to remove more than 10m² of non-friable asbestos. This course is suitable for anyone working in the building, construction, civil construction and demolition sectors who may be required to remove non friable (bonded) asbestos either in structures or soils.

LICENSING

In NSW, Participants who successfully complete this course can apply for a Class B - Remove Non Friable Asbestos licence, subject to meeting the SafeWork NSW criteria and standards. LOCATION AND DURATION

Courses are delivered at various MBA Offices (refer to our website for locations) and can also be delivered on-site if suitable areas are available to complete practical assessments.

ENTRY REQUIREMENTS AND PRE-REQUISITES

There are no educational entry requirements for this course however participants must:

- Complete the Asbestos Awareness online course prior to course commencement. This course is included in the price for the Remove Non Friable Asbestos cost.
- Be over 18 years of age
- Have a Valid White Card (general construction induction card) issued after September 2009
- Be proficient in spoken and written English, as the assessments must be undertaken in English
- Bring original identification on the morning of the course

COURSE MATERIALS

Participants are not required to bring any materials or purchase specific books to complete this course. A pen and notepad for individual note taking is recommended. Master Builders will provide all course materials, resources and access to PPE (including respirators, gloves, disposable overalls, safety glasses, etc) on the training day.

NATIONALLY RECOGNISED TRAINING



Participants who successfully complete this nationally recognised unit of competency, will be issued a Statement of Attainment for:

- CPCCDE3014A Remove non-friable asbestos

COURSE DELIVERY AND ASSESSMENT

This unit of competency covers the following topics:

- Plan for asbestos removal
- Prepare asbestos removal area and removal site
- Isolate removal site
- Carry out asbestos removal process
- Carry out decontamination process
- Clean-up work site
- Contribute to and documentation in line with regulatory requirements

This course is delivered and assessed face-to-face in a classroom with:

- Written assessments including a knowledge questionnaire consisting of short answer questions to be completed individually by the participant to obtain evidence of underpinning knowledge needed to perform asbestos removal activities at a competent level.
- Practical assessment conducted one-on-one or in a small group. Where a small group is assessed, the assessor will ensure all aspects of assessment are clearly assessed for each participant in the group (this may involve tasks being completed more than once to ensure each participant is competent).
- Participants will also be assessed on their observable behaviour including oral questions to assess technical criteria relevant to techniques required for this unit of competency.

Participants are provided with a briefing of what is required to successfully complete the assessment; to ensure they are completely aware of the conduct of assessment as well as the required skills, knowledge and behaviour the assessor is looking for within the assessment.

Participants are offered multiple opportunities to demonstrate knowledge and skills throughout the program. At the completion of all the assessment tasks the participant will be provided feedback on their abilities and responses.

CERTIFICATION

On successful completion of the online Asbestos Awareness course, Participants will be issued with a statement of completion for Asbestos Awareness from Master Builders

If a participant is assessed as 'Competent' in this unit of competency, they will progress to the Master Builders certification process for the Statement of Attainment of CPCCDE3014A Remove non-friable asbestos as described in the Participant Handbook.

If a participant is assessed as 'Not Yet Competent' in this unit of competency they will not receive a Statement. They are invited to re-enroll into this course again any time, at the full course fee.

FEES AND CHARGES

Information about Master Builders fees, charges, refunds and withdrawals is provided in the Participant Handbook, which is available on our website. The fee for this one day course is:

- \$349 per person for Master Builder's Members
- \$435 per person for Non-Members

All fees are GST exempt.

CLOTHING REQUIREMENTS

Whilst undertaking this course, participants must wear closed footwear and appropriate clothing suitable for a work environment (no thongs, singlets, shorts etc).

UNIQUE STUDENT IDENTIFIER (USI)

Any person undertaking nationally recognised training in Australia is required to have a Unique Student Identifier (USI). Master Builders cannot issue a Certificate or Statement of Attainment to a participant who does not have a USI. Master Builders will request the participant creates their USI prior to course commencement. If this is not possible Master Builders have facilities at their training centres for the participant to create their USI prior to course commencement with the assistance of Master Builders' staff.
